ARTICLES OF INCORPORATION

ARTICLE I - NAME

The name of the corporation is Port Malabar Blvd. Texaco of Palm Bay, Inc., 3369 Fan Palm Blvd., Melbourne, FL 32901. (Principal Office and Registered Agent).
