**ARTICLES OF INCORPORATION
OF
ALL FLORIDA UROLOGY ASSOCIATES, INC.**

The undersigned, acting as Incorporator for the purpose of forming a Corporation under the provisions of the Florida Business Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE ONE
NAME**

The name of the corporation is All Florida Urology Associates, Inc. (hereinafter called the "Corporation").

**ARTICLE TWO
PRINCIPAL OFFICE**

The principal office and mailing address of the Corporation is 111 Second Avenue, N. E., Suite 1201, St. Petersburg, Florida 33701.

**ARTICLE THREE
CAPITALIZATION**

The aggregate number of shares of stock which the Corporation is authorized to issue is 10,000 shares of Common Stock, par value \$1.00 per share. The shares shall be evenly divided into two (2) classes: Class A Common Stock and Class B Common Stock. The only difference between the two classes shall be in voting rights. Class A Common Stock may vote on all matters except the sale of assets, merger, reorganization, or dissolution of the Corporation and Class B Common Stock may vote on all matters including the sale of assets, merger, reorganization, or dissolution of the Corporation.

**ARTICLE FOUR
REGISTERED OFFICE AND AGENT**

The address of the Corporation's initial registered office is 111 Second Avenue N.E., Suite 1201, St. Petersburg, Florida 33701, and the name of its initial registered agent at such office is William H. Tushinski.

**ARTICLE FIVE
DIRECTORS**

The business of the Corporation shall be governed by a board of directors. The number of directors on the Board of Directors shall be set forth in the bylaws of the Corporation, as amended from time to time but shall never be less than one (1).


**ARTICLE SIX
INCORPORATOR**

The name and address of the incorporator of the Corporation is: William H. Tushinski, 111 Second Avenue N.E., Suite 1201, St. Petersburg, Florida 33701.

**ARTICLE SEVEN
INDEMNIFICATION**

The Corporation shall indemnify any officer or director, or any former officer or director, to the fullest extent permitted by law.



Pursuant to the provisions of Sections 607.1005 and 607.1006 of the Florida Business Corporation Act, All Florida Urology Associates, Inc., a Florida corporation, hereby adopts the following Articles of Amendments to its Articles of Incorporation:

ARTICLE I

Name

The name of the corporation is All Florida Urology Associates, Inc. (the "Corporation").

ARTICLE II

Text of Amendment

Article Three of the Corporation's Articles of Incorporation is deleted in its entirety and the following is substituted in its stead:

ARTICLE THREE

Capitalization

The aggregate number of shares of stock which the Corporation is authorized to issue is 10,000 shares of Common Stock, par value \$1.00 per share.

ARTICLE III

Date and Manner of Adoption

The amendment was adopted on December 11, 1996 by the sole incorporator of the Corporation. Because the Corporation has not issued any stock, shareholder approval was not required.
