**ARTICLE I**

The name of the corporation shall be **GREATER CONTROL MANAGEMENT CORP.**

**ARTICLE II**

The corporation may engage in any activity or business permitted under the laws of the United States and of the State of Florida.

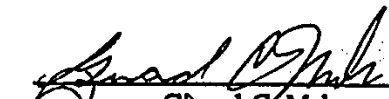
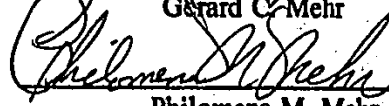
