## ARTICLES OF INCORPORATION OF

The undersigned, for the purpose of forming a corporation under the  $FLOR_{IDA}$  Florida General Corporation Act, do hereby adopt the following Articles of Incorporation:

ARTICLE 1. NAME.

The name of the corporation is: ANAR'S SERVICE,

INC

ARTICLE 2. DURATION. The duration of the corporation is perpetual.

ARTICLE 3. PURPOSE. The general purposes for which the corporation is organized are the following:


- A. To engage in and transact any lawful business for which corporations may be incorporated under the Florida General Corporation Act. No other purpose limits this general purpose in any way.
