The undersigned subscribers to these Articles of Incorporation are natural persons competent to contract and form a corporation under the laws of the State of Florida, and do certify that they have become a corporation under and pursuant to the following Articles of Incorporation. EFFECTIVE DATE

I.

Jan 1, 1997 The name of this corporation is Alton Homes, Inc.

II.

The general nature of the business to be transacted by this corporation is:

- 1. To conduct business in, have one or more offices in, and buy, hold, mortgage, sell, convey, lease or otherwise dispose of real and personal property, including franchises, patents, copyrights, trademarks, and licenses, in the State of Florida and in all other states and countries.
- 2. To carry on and conduct a general contracting business, including the designing, construction, enlarging, repairing, remodeling, or otherwise engaging in any work upon buildings, roads, side walks, highways, bridges, or manufacturing plants; and to engage in iron steel, wood, brick, concrete, stone, cement, masonry, and earth construction, and to execute contracts or to receive assignments of contracts therefor, or relating thereto; also, to manufacture and furnish the building materials and supplies connected herewith.
