ARTICLES OF AMENDMENT  
TO THE  
ARTICLES OF INCORPORATION  
OF  
COX POOLS SUPPLY, INC.

Pursuant to the provisions of Chapter 607 of the Florida statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: ~~The name of the Corporation is Cox Pools Supply, Inc.~~

SECOND: The following amendment of the Articles of Incorporation of the Corporation was adopted by the Stockholders and Directors of the Corporation effective August 12, 1997, in manner prescribed by the Florida Statutes:

"The Articles of Incorporation of the Corporation are amended by deleting Article I and Articles III of the Articles of the Incorporation and substituting in lieu thereof the following new Article I and Article III:

"Article I"
