#### TO THE

#### ARTICILES OF INCORPORATION

Pursuant to the provisions of Chapter 607 of the Florida statutes, the undersigned Corporation adopts the following Articles of Amendment to its Articles of Incorporation:

FIRST: The name of the Corporation is Cox Pools Supply, Inc.

SECOND: The following amendment of the Articles of Incorporation of the Corporation was adopted by the Stockholders and Directors of the Corporation effective August 12, 1997, in manner prescribed by the Florida Statues:
