The undersigned, being the sole incorporator to these Articles of Incorporation, competent to contract, hereby forms a corporation under the laws of the State of Florida.

ARTICLE I NAME

The name of the Corporation is X-CLUSIVE VIDEO, INC. II.

ARTICLE II DURATION

This corporation shall have perpetual existence, existence shall commence upon the time of filing and continue until terminated by unanimous agreement of the members.

ARTICLE III **PURPOSES**
