## ARTICLES OF INCORPORATION

OF

## P&G TRANSITIONS PLUS, INC.



The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I

The name of the corporation is P&G Transitions Plus, Inc. The principal address is 5156 Shadowlawn Avenue, Tampa, Florida 33610.

### **ARTICLE II**

The duration of the corporation is perpetual.

#### **ARTICLE III**

The general purpose for which the corporation is organized is:

- 1. To engage in the all phases of business to finish and sell wood trim.
- 2. To transact any other lawful business for which corporations may be incorporated under the laws of Florida.
