

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

**ARTICLE I**

The name of the corporation is P&G Transitions Plus, Inc. The principal address is 5156 Shadowlawn Avenue, Tampa, Florida 33610.

**ARTICLE II**

The duration of the corporation is perpetual.

**ARTICLE III**

The general purpose for which the corporation is organized is:

1. To engage in the all phases of business to finish and sell wood trim.
2. To transact any other lawful business for which corporations may be incorporated under the laws of Florida.
3. To do such other things as are incidental to the foregoing or necessary or desirable in order to accomplish the foregoing.
