ARTICLE X

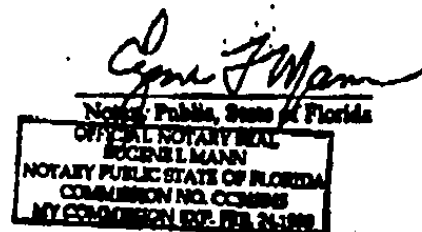

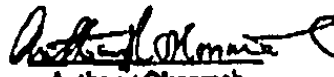
