THE UNDERSIGNED, acting as sole incorporator of WKH INVESTMENTS AND HOLDING COMPANY II (hereinafter the "Corporation") under the Florida Business Corporation Act, Chapter 607 of the Florida Statutes, as hereafter amended and modified (the "FBCA") hereby adopts the following Articles of Incorporation (the "Articles") for the Corporation:
