In compliance with the requirements of Florida Statutes Chapter 607, the undersigned, being a natural person, does hereby act as Incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

ARTICLE I - NAME AND ADDRESS OF CORPORATION

The name of this corporation is MORTON MORRIS, D.O., J.D., P.A. The street address of the initial principle office of this corporation is 512 PALM DRIVE, HALLANDALE, FLORIDA 33009.

ARTICLE II - PURPOSE OF CORPORATION

The general purpose for which the corporation is organized is the practice of law and other related activities.

ARTICLE III - CAPITAL STOCK

The maximum number of shares this corporation is authorized to issue is one hundred (100), all of which shall be common shares. Such shares shall have a par value of \$1.00.

ARTICLE IV - INITIAL REGISTERED OFFICE AND AGENT

The initial street address of the corporation's registered office is 512 PALM DRIVE, HALLANDALE, FLORIDA 33009. The initial registered agent for the corporation at that address is MORTON MORRIS.

The corporation shall indemnify its directors, officers, employees and agents to the fullest extent permitted by law.

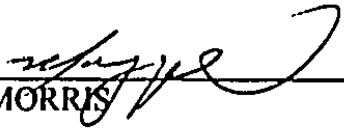
