ARTICLE I. NAME AND ADDRESS

The name and address of this corporation shall be WEST COAST MARINE, INC., 6610 NAUTICAL ISLE, HUDSON, FL 34667.

ARTICLE II. COMMENCEMENT & DURATION

The commencement of this corporation's existence shall be at the time of the filing of these Articles Of Incorporation by the Florida Department of State. This corporation's duration shall be perpetual.
