The undersigned subscriber to these Articles of Incorporation hereby forms a corporation under the Florida General Corporation Act.

ARTICLE I

NAME

The name of the corporation shall be SUPERIOR ENTERPRISE AGENCIES, INC., and whose business address is:

ARTICLE II

DURATION

The corporation shall have a perpetual existence.

ARTICLE III

BUSINESS AND ACTIVITIES

This corporation may, and is authorized to, engage in any activity or business permitted under the laws of the United States and of the State of Florida.

(a) Superior Travel: - shall perform, contract services, agreements, and arrangements to fulfill or carry out activities as a seller of national, international, or worldwide tourism services.

(b) Superior Limousine: - Engage in any activity permitted under the laws of the United States and the State of Florida for the transportation or services related for tourist or general public.
