ARTICLES OF INCORPORATION
OF
EMMANUEL C. JAVIER, M.D., P.A.

The undersigned, acting as incorporator of a corporation under the Florida Professional Service Corporation and Limited Liability Company Act, adopts the following articles of incorporation for such corporation:

ARTICLE I
Name

The name of the corporation is: Emmanuel C. Javier, M.D., P.A. (the "Corporation").

ARTICLE II
Principal Office and Mailing Address

The principal office and mailing address of the Corporation is 3010 East 138th Avenue, Tampa, Florida 33613.

ARTICLE III
Nature of Business

The Corporation is organized to engage in every aspect of the business of rendering the professional services to the public that a physician, duly licensed under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees, and agents of the Corporation who are duly licensed under the laws of the State of Florida to render services as a physician therein, and to engage in any and all other lawful business.

ARTICLE IV
Stock

The Corporation shall have authority to issue one thousand (1,000) shares of One Dollar (\$1.00) par value common stock.

ARTICLE V
Initial Registered Agent and Office

The street address of its initial registered office is 101 East Kennedy Boulevard, Suite 1030, Tampa, Florida 33602 and the name of its initial registered agent at that address is Buchanan Ingersoll Professional Corporation.

ARTICLE VI
Incorporator

ARTICLE VII
Initial Director

The Corporation shall have one director initially. The initial director is Emmanuel C. Javier, M.D., and his address is 3010 East 138th Avenue, Tampa, Florida 33613.


ARTICLE VIII
Shareholders

Shares of the Corporation's capital stock shall be issued only to individuals who are duly licensed to render services as a physician under the laws of the State of Florida. No shareholder of the Corporation may sell or transfer his or her shares of stock therein except to another individual who is eligible to be a shareholder of the Corporation.

ARTICLE IX
Voting Trusts

No shareholder of the Corporation shall enter into a voting trust agreement or any other type of agreement vesting in another person the authority to exercise the voting power of any or all of his or her shares.
