ARTICLES OF INCORPORATION OF EMMANUEL C. JAVIER, M.D., P.A.

The undersigned, acting as incorporator of a corporation under the Florida Professional Service Corporation and Limited Liability Company Act, adopts the following articles of incorporation for such corporation:

ARTICLE I Name

The name of the corporation is: Emmanuel C. Javier M. H., P.A. (the "Corporation").

ARTICLE II Principal Office and Mailing Address

The principal office and mailing address of the Corporation is 3010 East 138th Avenue, Tampa, Florida 33613.

ARTICLE III Nature_of_Business
