


Article 1, Name and Address, be and it hereby is amended to read as follows:

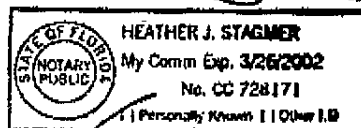
