

ARTICLES OF INCORPORATION

OF

SECULARIZE FLOOR

The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation:

ARTICLE ONE - NAME AND ADDRESS

The name of the corporation shall be L. Mac & Co., Inc. The principal place of business of this corporation shall be P.O. Box 11 Boynton Beach, Florida 33435.

The term of the corporation's existence is perpetual.
