After entering all of the required information when filing online, including the payment information, a confirmation number is automatically provided at that time. It does not sound like you completed all of the information, especially since you cannot provide the confirmation number.

Was your credit card charged? Or if you paid through an electronic filing account, was it charged? If you were not charged, that is another reason to assume that you did not complete the required information when filing online.

What you may do now is submit (by mail) the completed second notice form with the \$150 fee and a letter stating that you attempted unsuccessfully to file online before the due date. You should not be charged the late fee if you follow these instructions.
