

The undersigned, for the purpose of forming a professional corporation under the laws of the State of Florida pursuant to the provisions of Chapters 607 and 621, Florida Statutes, hereby adopts the following Articles of Incorporation.

**ARTICLE I**

**NAME**

The name of the corporation is JACK G. HAND, JR., P.A.

**ARTICLE II**

**NATURE OF BUSINESS**

The general nature of the business to be transacted by this corporation is:

To engage in every phase and aspect of the business of rendering to the public the same professional services that an attorney at law duly licensed under the laws of the State of Florida is authorized to render, but such professional services shall be rendered only through the corporation's officers, employees and agents who are duly licensed or otherwise legally authorized under the laws of the State of Florida to practice law in such state.

To invest its funds in real estate, mortgages, stocks, bonds or any other type of investments and to own real and personal property necessary for the rendering of the above described professional services.

**ARTICLE III**

**PRINCIPAL OFFICE**

The principal office and original mailing address of the corporation is 200 W. Forsyth Street, Suite 1000, Jacksonville, Florida 32202.

**ARTICLE IV**

**CAPITAL STOCK**

A. Authorized Capital. This corporation is authorized to issue one thousand (1,000) shares of the par value of one dollar (\$1.00) each, which shall be designated "Common Shares."

B. Proemptive Rights. Every shareholder, upon the sale for cash of any new stock of this corporation of the same kind, class, or series as that which he or she already holds, shall have the right to purchase his or her pro rata share thereof (as nearly as may be done without the issuance of fractional shares) at the price at which it is offered to others.

#### **ARTICLE V**

##### **INITIAL REGISTERED OFFICE AND AGENT**




