ARTICLES OF INCORPORATION

OF

CANDITO & JONES ONE, INC.

ARTICLE I. Name and Initial Address

The name of this corporation is CANDITO & JONES ONE, INC. and initial address of the corporation is P.O. Box 11084, Naples, Florida 34101.

ARTICLE II. Duration

This corporation shall exist perpetually commencing on the date of execution and acknowledgment of these articles.

ARTICLE III. Purpose

This corporation is organized for the purpose of transacting any or all lawful business.

ARTICLE IV. Capital Stock
