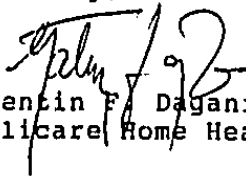

The undersigned subscribers in these articles of incorporation, natural persons competent to contract, hereby form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The name of the corporation is: QUALICARE HOME HEALTH INC.

ARTICLE II - NATURE OF BUSINESS

The nature of the business to be transacted by this corporation are:

1. To engage in the business of providing Home Care nursing and related health services.
2. To carry on any other business in connection with the foregoing, permitted under the laws of the United States and the State of Florida.

ARTICLE III - CAPITAL STOCK

The maximum number of shares of stock that this corporation is authorized to have outstanding at any given time is 10,000 shares of common stock having a par value of Ten and no/100th Dollars (\$10.00) per share.

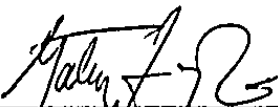

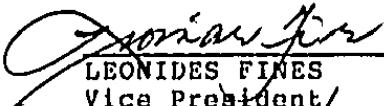
The registered resident agent for this corporation shall be indicated on the attached Certificate and the said agent may be replaced in accordance with the by-laws.


ARTICLE XI - AMENDMENTS

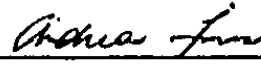
