

OF

ARTICLE I: CORPORATE NAME AND PRINCIPAL OFFICE

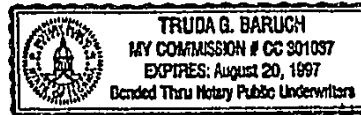
