

I, the undersigned, acting as the Incorporator of corporation under the Florida General Corporation Act, hereby adopt the following Articles of Incorporation for such corporation:

ARTICLE I. NAME

The name of this corporation is Loucan Enterprises, Inc. The principle location of the corporation is 14557 Anchorage Cir., Largo, FL 33776.

ARTICLE II. DURATION


