#### ARTICLES OF INCORPORATION

OF

# MILLER'S MARINE GROUP, INC.

The undersigned, acting as incorporators of a corporation under the Florida General Corporation Act, adopt the following Articles of Incorporation for such corporation:

#### ARTICLE ONE: NAME

The name of this corporation shall be: MILLER'S MARINE GROUP, INC.

#### ARTICLE TWO: GENERAL PURPOSE
