

ARTICLES OF INCORPORATION

MEDPEND, INC.

ARTICLE I. NAME. The name of the Corporation is MedPeno, INC.

ARTICLE II. DURATION. This Corporation shall have perpetual existence.

ARTICLE III. PURPOSE. This Corporation is organized to transact and carry on any activity or business permitted under the laws of the United States and the State of Florida.

The name of the initial registered agent of this Corporation at the immediate foregoing address is Timothy H. Pendry.

ARTICLE VIII. PRE-EMPTIVE RIGHTS. Each shareholder, upon the sale for cash of any new stock of this Corporation of the same kind, class or series as that which he already holds, shall have the right to purchase his pro rata share thereof (as nearly as may be done without issuance of fractional shares) at the same price per share at which shares are offered to others.

ARTICLE IX. AMENDMENTS. These Articles of Incorporation may be amended in the manner provided by law. Every amendment shall be approved by the shareholders representing a majority of the outstanding shares of the Corporation entitled to vote thereon.
