ARTICLE ONE

The name of the corporation is **VIC & SON HOLDINGS, INC.** The principal address of the corporation is: 9101 Sunset Strip, Sunrise, Florida 33322.

The aggregate number of shares which the corporation shall have authority to issue is **one hundred (100)** of **no par value**.


ARTICLE FIVE


ARTICLE EIGHT
