ARTICLE I

NAME OF CORPORATE ENTITY: The name of the corporation shall be CENTRAL FLORIDA SUN & FUN, INC.

ARTICLE II

EXISTENCE: The duration of the corporation shall be perpetual; commencement of the corporation's existence shall begin as of the filing of the Articles of Incorporation by the Department of State.

ARTICLE III

GENERAL PURPOSES: The general purpose for which this corporation has been organized is to the transaction of any and all lawful business for which corporations may be incorporated under the laws of the State of Florida or the laws of the United States.
