The undersigned adopts the following Articles of Incorporation to form a corporation under the laws of the State of Florida.

ARTICLE I - NAME

The corporation shall commence its existence on January 1, 1997 and shall exist perpetually unless sooner dissolved according to law.


ARTICLE IX - AMENDMENTS TO ARTICLES
