ARTICLES OF INCORPORATION

Global Communications Link, Inc.

The undersigned, acting as incorporator of a corporation pursuant to Chapter 607, Florida Statutes, adopts the following Articles of Incorporation:

Article I

Name

The name of the corporation shall be:

Article II

Principal place of Business and mailing address

The principal place of business and the mailing address of this corporation shall be:

Article III

Purpose(s)

The specific purpose(s) for which the corporation is organized are:

- *to serve the general population by collecting the most accurate and authoritative information possible about Nigeria, Africa and Africans in general, and to present it in a format that provides all individuals and organizations who has interest in Africa, an objective representation of cultural, commercial and social diversification of these nationalities.*
- *to engage in any lawful business activities including the purchasing, leasing, renting, selling, holding and otherwise acquiring and disposing of real estate and personal property, both tangible and intangible, and chooses in action, either as owner, broker, agent or factor.*
- *to engage in the purchase or acquisition of property, business rights of franchise, or for additional working capital, or for any other object in or about its business affairs, and without limit as to the amount, to incur debts, and to raise, borrow and secure the payment of money in any lawful manner, including the issue and sale of other dispositions of bonds, warrants, debentures, obligations, negotiable and transferable instruments and evidence of indebtedness of all kinds whether secured by mortgage, pledge, deed of trust or otherwise.*

The foregoing purposes and activities will be interpreted as examples only and not as limitations, and nothing therein shall be deemed as prohibiting the organization from extending its activities to any related or otherwise permissible lawful business purposes which may become necessary for the furtherance of the organizational objectives expressed above.

Article IV
Capital Stock

The number of shares of stock that this corporation is authorized to have outstanding at any time shall be 50,000 shares of \$1.00 par value. This corporation shall do business with a capital of not less than \$25,001 (twenty five thousand, one dollars).
