ARTICLES OF INCORPORATION

OF

RICE NECKLACES INTERNATIONAL, INC.



The undersigned, for the purpose of forming a corporation under the Florida General Corporation Act, does hereby adopt the following Articles of Incorporation:

ARTICLE I

The name of this corporation shall be RICE NECKLACES INTERNATIONAL, INC.

ARTICLE II
