

ARTICLES OF INCORPORATION OF



Lehigh Showcase Capital Corporation

ARTICLE I Corporate Name

The name of this corporation is: Lehigh Showcase Capital Corporation.

ARTICLE 11 Nature Of Business And Powers

The general nature of the business to be transacted by Lehigh Showcase Capital Corporation is to engage in any and all business permitted under the laws of the State of Florida.

ARTICLE III Capital Stock

The maximum number of shares of stock that Lehigh Showcase Capital Corporation is authorized to issue and have outstanding at any one time is 1000 shares of common stock without par value.

ARTICLE IV Term Of Existence
