OF

The undersigned, acting as incorporator of a corporation under the Florida General Corporation Act, adopts the following Articles of Incorporation for such corporation:

ARTICLE I

The name of the corporation is MISSOURI FARMS, INC.

ARTICLE II

The principal office of the corporation is 1603 Alexander Crossing Way, Sun City Center, Florida 33573.

ARTICLE III

The period of duration of the corporation is perpetual.

ARTICLE IV

The purpose or purposes for which the corporation is organized are to engage in any activity or business permitted under the laws of the United States and of this state.

ARTICLE V

The corporation is authorized to issue 200 shares of the capital stock of the corporation which shares shall consist of:

- A. 100 shares of common voting shares having a par value of \$5.00 each.
- B. 100 shares of common non-voting shares having a par value of \$5.00 each.

Except for the voting rights belonging to the common voting shares, the common voting shares and the common non-voting shares shall be identical in all respects and shall have equal rights and privileges.

The holders of the shares of common non-voting stock shall not be entitled to any voting powers at any shareholders' meeting.

The holders of the shares of the common voting stock shall possess full voting rights on all matters voted or by the shareholders of the corporation.

ARTICLE VI

The street address in Florida of the initial registered office of the corporation is 1603 Alexander Crossing Way, Sun City Center, Florida 33573; and the name of the initial Registered Agent at such address is B. B. SLAUGHTER.

ARTICLE VII

This corporation shall have four directors initially. The number of directors may be either increased or decreased from time to time by an amendment of the bylaws of the corporation in the manner provided by law, but shall never be less than four. 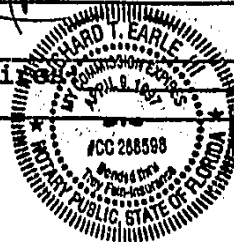
