(ASSIGNMENT OF STOCK)

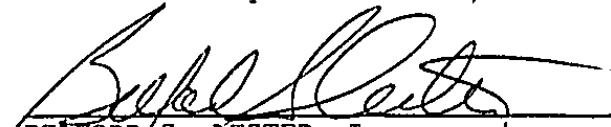
No shareholder of this corporation may assign or sell shares in contravention of any provision in the by laws or shareholders' agreement of the corporation.

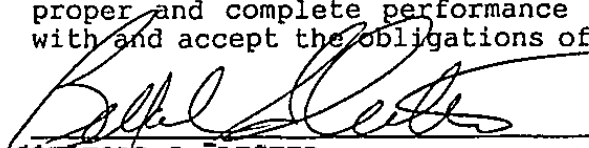
