**ARTICLE I
Corporate Name**

The name of this corporation is: Southern Style Homes, Inc..

**ARTICLE II
Nature Of Business And Powers**

The general nature of the business to be transacted by Southern Style Homes, Inc. is to engage in any and all business permitted under the laws of the State of Florida.

**ARTICLE III
Capital Stock**

The maximum number of shares of stock that Southern Style Homes, Inc. is authorized to issue and have outstanding at any one time is 1000 shares of common stock without par value.

**ARTICLE IV
Term Of Existence**

Southern Style Homes, Inc. shall have perpetual existence, commencing upon filing of these articles.
