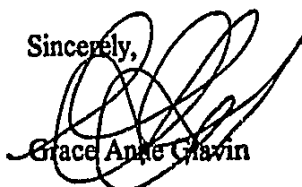

The Undersigned, acting as incorporators of this business corporation pursuant to Chapter 607 of the Florida Statutes, hereby forms a Business Corporation under the laws of the State of Florida and adopts the following Articles of Incorporation for such corporation:

**ARTICLE I - NAME OF CORPORATION**

The name of the corporation shall be SEMINOLE RECYCLING, INC.

**ARTICLES II - TERM OF EXISTENCE**

This corporation shall begin its corporation existence as of the 9th day of December, 1996, and shall exist perpetually.

**ARTICLES III - GENERAL PURPOSE**

The general purpose for which this corporation is organized shall be Metal Recycling and to do all things in connection therewith that are related services and sales by a Metal Recycling company under the laws of the State of Florida. The business of the corporation shall be limited to the foregoing activities.
