ARTICLE ONE

The name of the corporation is GEN EVENTS, INC.


ARTICLE EIGHT

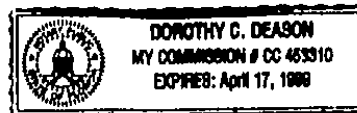


