ARTICLE ONE

The name of the corporation is GEN EVENTS, INC.

The duration of this corporation is perpetual.



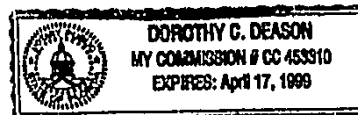
