

The undersigned being duly licensed to practice Veterinary Medicine in the State of Florida and desiring to form a professional corporation in accordance with the Florida Business Corporation Act and the Florida Professional Service Corporation and Limited Liability Company Act, hereby adopts the following Articles of Incorporation:

**ARTICLE I. NAME & ADDRESS**

The name of the professional service corporation is:

**HUGH W. CALDERWOOD V.M.D., P.A.**

The principal place of business of this corporation will be

**ARTICLE II. NATURE OF BUSINESS**

The purpose for which the corporation is organized is to engage in and carry on all branches of the practice of Veterinary Medicine within the State of Florida, and to do those things that are necessary or proper in connection with that practice.

**ARTICLE III. ELECTION UNDER PROFESSIONAL CORPORATION ACT**
