#### ARTICLES OF INCORPORATION

#### ARTICLE I. CORPORATE NAME

The name of this corporation is: BOMBINO-MASI - TILAPIA AQUACULTURE INTERNATIONAL, INC., where the principal office is: 10510 Branchtonchurch Road, Thonotosassa, FL 33592.

#### ARTICLE II. NATURE OF BUSINESS AND POWERS.

The general nature of the business to be transacted by this Corporation is to engage in any and all business permitted under the laws of the State of Florida.

#### ARTICLE III. CAPITAL STOCK.

The aggregate number of shares which this corporation shall have authority to issue is 2,500, shares of common stock having a NONE Par value per share.
