## ARTICLES OF INCORPORATION

the undersigned, in order to form a Corporation for the purpose hereinafter stated, under and pursuant to the Corporation laws of the State of Florida and the acts amendatory thereof and supplemental thereto, do hereby certify as follows:

#### ARTICLE I

The name of the Corporation shall be :

- D) To enter into, make amend perform contracts of every kind with any person, firm, association or corporation, municipality, political body, country, territory, state government or colony or dependency or agency thereof;
- E) To purchase, hold and reissue any of the shares of its capital stock;
- F) In general, to do each and everything necessary, suitable and proper for the accomplishment of any of the purposes or the attainment if any of the objects of the furtherance of any of the powers herein above set forth, whether alone or in association with other Corporations, firm, or individuals, and to carry on any business, and to have all the powers in connection therewith, not forbidden by the laws of the State of Plorida, and to do every other act or acts, thing or things, incidental or appurtenant to or growing out of or connected with the aforesaid objects or purposes or any part or parts thereof.
