ARTICLES OF AMENDMENT OF THE ARTICLES OF INCORPORATION OF OCCULOGIX CORPORATION



Occulogix Corporation, a corporation organized and existing under the laws of the State of Florida (the "Corporation"), in order to amend its Articles of Incorporation in accordance with the requirements of Chapter 607, Florida Statutes, does hereby certify as follows:

- The Articles of Incorporation of the Corporation were filed by the Secretary of State of the State of Florida on December 13, 1996 and were amended on April 10, 1997, June 6, 1997, January 12, 1998 and April 29, 1998.
- 2. The Corporation is currently authorized to issue 55,000,000 shares divided into the following: (i) 1,000,000 shares of Series A Convertible Preferred Stock, \$.001 par value (the "Series A Preferred Stock"), (ii) 19,000,000 shares of Undesignated Serial Preferred Stock, \$.001 par value, (iii) 30,000,000 shares of Common Stock, \$.001 par value, and (iv) 5,000,000 shares of Non-voting Common Stock, \$.01 par value.
- 3. The Corporation desires to delete the authorization for the 1,000,000 shares of Series A Convertible Preferred Stock (the "Series A Preferred Stock"), because no shares of such Stock are or have been issued.
- 4. The Corporation is authorized to delete the 1,000,000 shares of Series A Preferred Stock from its authorized capitalization without shareholder approval pursuant to 607.1002(5).

- 5. Nothing in this Amendment shall affect the rights of stockholders of any other class of stock of the Corporation.
- 6. This Amendment to the Articles of Incorporation was approved by the board of directors, as of November 5, 1998.
