

The undersigned, for the purpose of forming a corporation under the Florida Business Incorporation Act, hereby adopts the following articles of incorporation:

ARTICLE ONE

NAME

The name of the corporation is RBMS, INC.

DURATION

The term of duration of the corporation is perpetual.

INCORPORATORS






