I am writing to request your help in a situation. I was recently informed about from the Florida Lottery.

I started a Corporation in Florida in December 1996. In 1997, I received a booklet from the State Division of Corporations for the Annual Report and the amount due. I filled it out and mailed it back with the necessary fee.

I never received this booklet in 1998 or 1999.

May 15, 1999, I received a letter (copy enclosed) from the Florida Lottery informing me they did an audit and found my Corporation had been dissolved. This information shocked me, so I called my accountant to ask him what this was all about. He explained the Annual Report and fees that were due must not have been paid. He called the Division of Corporations and requested the reinstatement form.

I went through all my papers and only found the front and back of the 1997 Annual Report.

I always pay my bills on time and

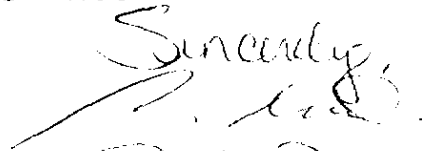
I save every paper I receive (except junk mail)

I do not believe I would have ever-
looked such an important document.

I am requesting that the reinstatement
fee be waived. Although I have a for-
profit corporation, I have a gas station/
convenience store in which I personally
work 10-12 hours per day. I do not make
the kind of money large for-profit
corporations make, so the \$600 fee is
sorry for me.

I hope you can understand and help
me with this situation.
