The undersigned subscribers to the Articles of Incorporation, being duly licensed to practice Law under the laws of the State of Florida, for the purpose of forming a corporation under the Florida Professional Service Corporation Act, hereby adopt the following Articles of Incorporation.

ARTICLE I

ARTICLE II


