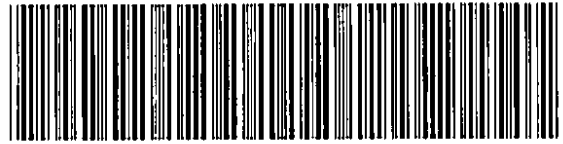

34205. The registered agent at the registered office is RONALD E. WITT."


