

In compliance with the requirements of F.S. Chapter 607, the undersigned, being a natural person, does hereby act as the incorporator/Domestication in adopting and filing the following Articles of Incorporation for the purpose of organizing/domesticating a business corporation.


ARTICLE IV

The Corporation shall indemnify its directors, officers, employees, and agents to the fullest extent permitted by law.


