ARTICLES OF INCORPORATION

OF

R.J. SINGER M.D. RADIOLOGY, P.A.

The undersigned subscriber to these Articles of Incorporation hereby forms a professional service corporation under the Florida Professional Service Corporation and Limited Liability Company Act (the "Act").

ARTICLE I

<u>NAME</u>

The name of the corporation is R.J. SINGER M.D. RADIOLOGY, PA.

ARTICLE II

PRINCIPAL OFFICE AND MAILING ADDRESS

The corporation's principal office and its mailing address shall be 5000 University Drive, Coral Gables, Florida 33146.

ARTICLE III

DURATION AND COMMENCEMENT OF CORPORATE EXISTENCE

The corporation shall exist perpetually. The corporate existence shall commence upon filing of these Articles of Incorporation with the Department of State.

ARTICLE IV

NATURE OF BUSINESS

The purpose of the corporation and the nature of its business are as follows:

- 1. (a) To engage in every phase and aspect of the business of rendering the same professional services to the public that a doctor of medicine, duly licensed or otherwise legally authorized under the laws of the State of Florida, is authorized to render, but such professional services shall be rendered only through officers, employees and agents who are duly licensed or otherwise legally authorized under the laws of the State of Florida to render such professional services therein.
- (b) To buy, sell, deal in and exchange shares of its own capital stock, except that the corporation shall not issue any of its capital stock to anyone other than a professional corporation, a professional limited liability company or an individual who is duly licensed or otherwise legally authorized to render professional medical services within the State of Florida. No shareholder of this corporation shall enter into a voting trust agreement or any other type of agreement vesting another person with the authority to exercise the voting power of any or all of his stock.
- (c) To invest the funds of the corporation in real estate, mortgages, stock, bonds or any other type of investment, and to own real and personal property necessary for the rendering of professional services.
- (d) To do all and everything necessary and proper for the accomplishment of any of the purposes or the attaining of any of the objects or the furtherance of any of the purposes enumerated in these Articles of Incorporation or any amendment thereof, necessary or incidental to the protection and be cfit of the corporation, and, in general, either alone or in association with other

corporations, firms, or individuals, to carry on any lawful pursuit necessary or incidental to the accomplishment of the purpose or the attainment of the objects or the furtherance of such purposes or objects of the corporation.

(e) Without limiting the generality of any of the foregoing language, the corporation shall have all of the powers which are now or which may hereafter be conferred upon professional service corporations by the laws of the State of Florida.

ARTICLE V

CAPITAL STOCK

The corporation is authorized to have outstanding one class of stock, to be designated as Common Stock. The maximum number of shares of Common Stock which the corporation is authorized to have outstanding is One Thousand (1,000) shares of Common Stock having a par value of \$1.00 per share.

RESTRAINT ON ALIENATION

No shareholder may sell or transfer his shares in the corporation except to another professional corporation, professional limited liability company or individual, each of which must be eligible to be a shareholder of a professional service corporation under Florida law.

If any officer, shareholder, agent or employee of the corporation, who has been rendering professional medical service to the public, becomes legally disqualified to render such professional medical service within the State of Florida, or accepts employment that, pursuant to existing law, places restrictions or limitations upon his continued rendering of suc professional medical services, the corporation shall require him to sever all employment with, and financial interest in, the corporation forthwith.
