The undersigned subscriber to these Articles of Incorporation, a natural person competent to contract hereby forms a corporation under the laws of the State of Florida.

**ARTICLE I: NAME**

The name of the corporation shall be MARIA O. LOPEZ, M.D., P.A.

**ARTICLE II: NATURE OF BUSINESS**

This corporation is organized for the purpose of practicing medicine.

**EFFECTIVE DATE**  
12-12-96

**III: COMMENCEMENT OF BUSINESS**

This corporation may commence doing business five (5) days prior to the date of actual incorporation and may further ratify acts accomplished prior to said five (5) day period.

**ARTICLE IV: CAPITAL STOCK**

The maximum number of shares of stock that this corporation is authorized to issue at any one time is 1,000 shares of common stock with no par value.

**ARTICLE V: REGISTERED AGENT**

**ARTICLE IX: LIMITATION OF LIABILITY**

Any director of the corporation may vote upon any transaction with the corporation without regard to the fact that he is also a director of such subsidiary or corporation.

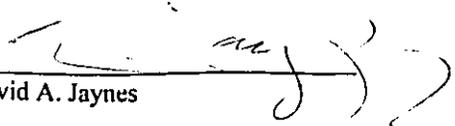
